# FROM LOST TO *Saved*

Cason and I have been together for four years. For the past three years, we struggled as a couple, and it got a little more complicated when we had a miscarriage; I didn't know I was pregnant until it was too late. It messed with me mentally; I was so confused and depressed, always asking what-if questions. Months passed, and we got the best news we were expecting again.

During my pregnancy, we struggled financially and had many complications in our relationship. When I went into labor, I was in labor for 7 hours. During those seven hours, our son wasn't cooperating; he didn't move once. The nurses had me lay in different positions, buzzing him with a baby buzzer (it didn't harm him, it was more

like a tickle for him), and they also had me drink lots of cold liquids but no response. After seven hours, his heart rate started dropping, making all of us concerned; the doctor decided to do an emergency c-section. I was so scared, but thankfully, Cason and my mother stuck by my side and gave me the best support. During the surgery, everything was going perfectly; after intense tugging on my organs and dry heaving, I heard our son's first cry. It was the most beautiful sound I've ever heard; Cason said, "he's so beautiful," and his face lit up! But sadly, the happiest moment ended when I lost a lot of blood and went unconscious; the nurses had to make Cason leave the room. I woke up in the recovery room; doctors said I lost a lot of blood and had to have surgery.



After an hour, I finally saw our son. It was amazing; I spent the night holding him in my arms. But not even 24 hours later, our son had to be transported to Albuquerque. Cason was flown out with him, and since it wasn't even 24 hours since my surgery, I couldn't go. Later, I traveled to Albuquerque with my brother. We finally arrived, and when I saw him, it was heartbreaking. He had an IV in his head and had so many cords hooked to him, as well as oxygen. The doctor said he had inflammation in his blood and would need antibiotics. He was also hypoglycemic, which put him at high risk for seizures, and he couldn't keep his oxygen above 95 percent. After a week in the NICU, we could finally go home, but our son would have to stay on oxygen. We were so excited to go home, but it wasn't easy. On the way home, our car overheated and shut off. After hours of being stranded and trying to fix the vehicle, an angel in disguise pulled over and helped us. Our car finally started, and he followed us halfway home to ensure our car didn't shut off again. We were finally home, and our son remained on oxygen for two months before being cleared by the doctor.

Five months later, when our son turned seven months, I noticed I was having pregnancy symptoms, and because of financial situations, I researched and found Grace Place. They were able to see me right away when I called. They gave me a pregnancy test, and the next thing I know, it was positive! I was so surprised and wasn't expecting another child so soon; I started crying, filled with worry. Mary, (the client advocate) did her best to comfort me and asked if she could pray for me. I don't remember the last time I prayed, but I felt so relieved when I did. On my way home, I gave Cason the news, and he was also shocked. He felt stressed because we were already struggling financially. We comforted each other, and I told him that I had a great feeling about Grace Place and wanted to continue going.

I am now 30 weeks pregnant, and our son will turn 1 in a few weeks. We've been coming to Grace Place for almost

six months. It was one of the best decisions we've ever made. Before Grace Place, we struggled as a couple. We had trust and commitment issues and the inability to compromise. Things were hard because Cason was not emotionally available. He was taught at a young age that "men should never show feelings." and not having a father in his life made him more stubborn. While attending weekly parenting classes, Cason met Armando and participated in "Men of Valor." It was a great program that helped Cason so much. Armando gave excellent advice to Cason; he taught him that he was more than just the financial provider in the family and that it was okay to make mistakes. Armando helped us so much through our issues; he taught us how to communicate and work through our problems healthier. When we decided to get married, Armando did our premarital counseling! He gave us great advice, and because of him, Cason and I are happily married! We have learned to forgive and help each other move on from the toxic past.

Before Grace Place, we also struggled as parents. Because we are first-time parents, and my recent diagnosis of depression and anxiety made things harder. Thankfully, Grace Place is a place where they are judgment-free and helped us. Once a week, we meet and watch educational videos on parenting and do worksheets. My favorite is earning baby bucks because of how helpful it is! We don't ever need to scrape up money again for diapers and clothes because they provide them.

Grace Place has been so helpful and made us feel welcomed. We went from lost, confused parents to parents who opened their hearts and accepted Jesus into our lives. The staff at Grace Place is like a second family to us. They are super helpful to our son, who loves seeing them whenever we go. I am very excited to continue our future with them and cannot wait to welcome baby number two into this world and introduce him to our Grace Place family.

## REACH

When you support Grace Place, you help us to be the hands and feet of Jesus to a broken world. Consider the facts:

- Roughly 121 million unintended pregnancies occurred each year between 2015 and 2019 around the world. Of these unintended pregnancies, 61% ended in abortion. This translates to 73 million abortions per year.
- New Mexico is an abortion tourism state. Abortions are legal through all 9 months of pregnancy. New Mexico does not have any state-level abortion restrictions—such as waiting periods, ultrasounds, parental notification, mandated parental involvement, or limitations on publicly-funded abortions. A 13-year-old can have an abortion, a surgical procedure, without her parents even knowing
- Approximately, 47% of New Mexico women who give birth, do so after an unintended pregnancy. In 2017, 51% of babies born in New Mexico were to unmarried women. In San Juan County 53% of babies born are to unmarried women.
- A 2015 study commissioned by Care Net surveyed 1,038 women who had abortions. 61% of these women surveyed discussed their decision to terminate their pregnancy with the father of the baby. More than 1/3 of women indicate the father of the baby was most influential in their abortion decision
- In 2021, 96% of moms who saw their baby on ultrasound at Grace Place CHOSE LIFE!

# ROE *Overturned*

The Supreme Court of the United States overturned more than 230 cases since 1810, but likely none of these have generated such controversy as the overturning of *Roe v. Wade*. Since the leak of an early draft of the Supreme Court's opinion, we have seen anger and false claims regarding what this overturn means for women and our state laws. We have seen protests and division among those that claim to be on the same side and some who have taken this moment to flaunt their previous abortions pridefully. Furthermore, some major companies have already changed their benefits packages, including travel compensation for employees who leave their states for abortions. Pro-abortion activists are sharing false information that the legal penalty for abortion will be more extreme for women who abort than for those who rape women. So many misconceptions are out there, making it even more challenging for women to navigate to the truth when they need real support and unbiased information.

## HERE ARE THREE OF THE MOST REPORTED FALSE CLAIMS WITH ACCURATE INFORMATION.

- 1. Women are being prosecuted for seeking or obtaining an abortion.** False; the reality is that there are no current state laws that specifically target women seeking an abortion. Instead, the laws typically focus on clinicians and prescribers who provide abortion. Medical professionals must abide by their licensing laws, which is no different when prescribing or performing abortion procedures. For example, in a state that permits abortions through 15 weeks of pregnancy, but an abortion provider chooses to provide it through 20 weeks gestation, that provider would violate the state law. This is true for all licensed healthcare professionals.
- 2. Women with life-threatening pregnancies, such as ectopic pregnancies, will not be able to obtain medical care legally in states that do not permit elective abortion, putting women at risk for harm or death.**



False; the reality is that no abortion laws in any state in America prevent treatment for women with ectopic pregnancies and other life-threatening conditions. Women with threatened miscarriages to ectopic pregnancies can legally obtain care in all states. This false statement derives from the misconception that removing an ectopic pregnancy is a type of abortion. That is not true. An ectopic pregnancy develops outside the uterus, typically in the fallopian tube.

Most of these embryos die spontaneously but can still cause life-threatening internal bleeding for the mother. The typical treatment is using medications or surgery to remove the embryo and possibly the fallopian tube. The bottom line is that the management of ectopic pregnancies remains the same pre and post-Roe.

**3. Abortion is needed because of the “hard cases” such as rape, incest, fetal anomalies, and danger to the mother’s life.** False. First, the American Association of Pro-life Obstetricians and Gynecologists (AAPLOG) reports that in America, the most challenging of cases—rape, incest, fetal anomalies, and danger to the mother’s life, is extremely rare – accounting for only 1-3% of all “abortions.” Second, it is essential to define the term abortion. The only purpose of “elective or induced abortion” is to end the baby’s life and no more. It is never done for the life of

the mother. It is a false narrative to say that abortion is necessary to save the mother’s life. In rare circumstances, separating the mother from her unborn baby may be medically necessary to save the woman’s life. When the baby is too young to survive outside of the womb, the unintended consequence of losing the baby’s life is not the same as an induced or elective abortion. When a life-threatening complication occurs after the 22nd week of pregnancy, a premature delivery may be performed, saving the life of both the woman and her baby.

## SO, WHAT IS THE TRUTH?

AAPLOG reported in a recent article that 75% of abortions are performed because the mother states she cannot afford the child, or the child would interfere with school, work, or the ability to care for other children. In addition, AAPLOG shares a study that 58% of women who aborted did so to “make others happy.” Guttmacher Institute (founded by Planned Parenthood) states that their abortion research reveals primary themes of financial constraints and lack of partner support.

All these statistics are not surprising to us at Grace Place. We know that women need healthcare advocates, accurate pregnancy information, tangible resources,

and ongoing support to make their own life-giving choice. **This is why we exist!**

We show love towards every woman, man, and family who needs support and unbiased information during some of the most challenging times. We support them with pregnancy testing; options consultation (including education on parenting and adoption, parenting and child raising, and abortion); pregnancy verification letters, medical services (early obstetrical ultrasounds, health screens, STD/STI testing, and referral for treatment); prenatal and parenting education; material assistance; sexual risk avoidance education; after-abortion recovery support; referrals for medical care; as well as referrals to vital community and public health resources. We do all this while meeting their spiritual, material, and emotional needs. We spend time with each woman and man, listening, answering their questions, and offering support and education. All of this is done so that they make an informed pregnancy decision.

Grace Place is a safe place for both women and men to slow down, take a breath, and decide what is best for them. This is their decision and should not be made impulsively. A recent study published by the Journal of American Physicians and Surgeons and reported by the Population Research Institute said that nearly three-quarters (73.8%) of women with a history of abortion

admitted that they experienced at least subtle forms of pressure to terminate their pregnancies. More than half of the women reported that the perceived pressure was significant enough to influence their decision to abort. Of the 987 women surveyed, more than half (58.3%) indicated that they decided to abort to make others happy. Nearly 30% of survey respondents admitted they feared losing their partner if they failed to terminate the pregnancy. The study also found that two-thirds of the women (66%) knew in their hearts that abortion was wrong. Many women (67.5%) said that the decision to terminate their pregnancies was one of the most complex decisions of their life.

At Grace Place, we understand that women and men face such a complex decision. Therefore, we do not receive state or federal funding and make no money off a woman's decisions. We offer life-affirming services to empower women and men to welcome their children into the world. We provide personalized care at no cost in a safe, respectful, compassionate, and confidential environment with professional staff and volunteers. By providing practical assistance and referrals to needed resources, our goal is to improve health outcomes for women and promote health and well-being for themselves, their children, and their families for generations to come.

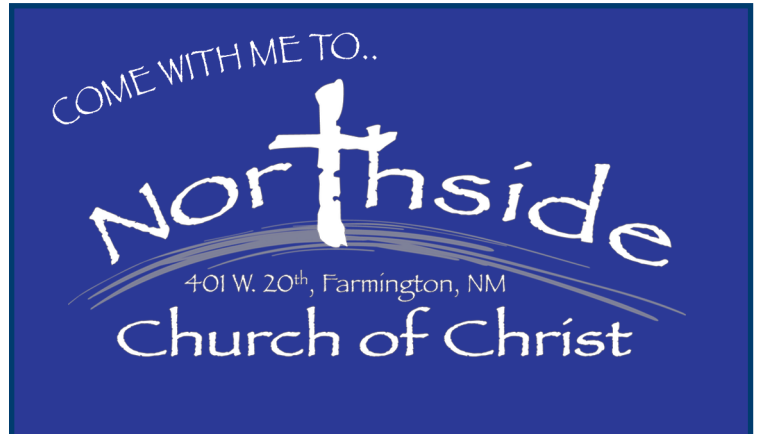

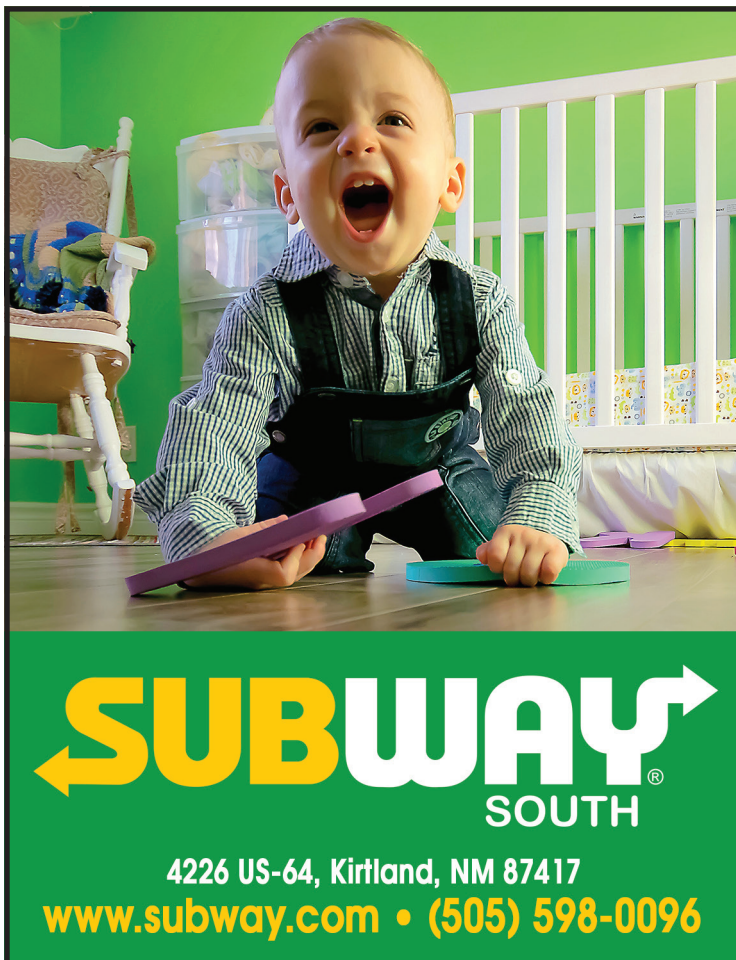


## Mary

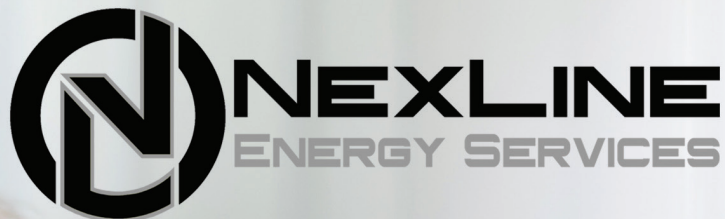
